2023-2024 On-Campus Employment during Official UF Breaks F-1 International Students & J-1 Exchange Visitors

The regulations of the Department of Homeland Security/United States Citizenship and Immigration Services (DHS/USCIS) and the Department of State (DOS) limit employment/training, etc. opportunities for <u>international</u> <u>students (F visa) & visitors (J visa).</u>

F-1* students and J-1** visitors who are maintaining status may work parttime on campus while classes are in session. "Part-time" means 20 hours or less per pay week (Friday-Thursday for UF; *the UF Bookstore and Chartwells Florida Fresh may have a different work week from UF, therefore, please verify/confirm the work week with employer prior to starting employment*).

* **F-1** students do not need specific authorization to work on-campus; it is automatically allowed within the F-1 regulations.

**** J-1** visitors need written authorization from their Exchange Visitor Advisor (Responsible Officer) of their exchange visitor program prior to being able to work on campus.

NOTE: All off-campus employment/training, etc., whether paid or unpaid/volunteer, optional/required, for both F-1 and J-1, is strictly prohibited without first applying for and receiving specific written authorization on the student's I-20 (F-1) or DS-2019 (J-1) or application to USCIS resulting in an Employment Authorization Document (EAD).

- Dates subject to change if the official UF calendar changes and affects when classes are in session.
- Working over (no cap) 20 hours per week during the dates allowed will not affect the F-1/J-1 international student's status.
- Remote for third party does not equate to on-campus.
- This document is updated by late September/early October each year, for the following December August. Students are limited to 20 hours or less per week at all times September November.
- All dates are in MONTH/DAY/YEAR order.

FALL/WINTER BREAK 2023

Fall 2023 classes end 12/06/2023.

A student who ... 1) is enrolled Fall 2023, and 2) expects to *graduate December 2023*

... is allowed to work over 20 hours per week on campus during the Fall/Winter break, from 12/07/2023 – *12/15/2023*.

Fall 2023 Commencement is on 12/16/2023 for most students.

A student who ...

is enrolled Fall 2023, and
will not graduate December 2023, and
expects to register in Spring 2024

... is allowed to work over 20 hours per week on campus during the Fall/Winter break, from 12/07/2023 - 01/07/2024.

Spring 2024 classes start 01/08/2024.

SPRING BREAK 2024

Spring Break 2024 is from 03/09/2024 - 03/16/2024.

A student who ... 1) is enrolled Spring 2024

... is allowed to work over 20 hours per week on campus during the Spring break, from 03/09/2024 – 03/16/2024.

Regarding Summer 2024

NOTE: Summer 2024 is **not** a break for students who were admitted to their current program in Summer A/B/C 2024 or whose status became effective/ reinstated in Summer 2024. It is a required semester and therefore limited to 20 hours per week.

SUMMER BREAK 2024 (See preceding NOTE regarding students admitted to Summer A/B/C)

Spring 2024 classes end 04/24/2024.

A student who ... 1) is enrolled Spring 2024, and 2) expects to *graduate May 2024*

... is allowed to work over 20 hours per week on campus during the Spring, from 04/25/2024 - 05/03/2024.

Spring 2024 Commencement is on 05/04/2024 for most students.

A student who ...

is enrolled Spring 2024,
will not graduate May 2024, and
expects to register in Summer B/C 2024 to graduate in August 2024

... is allowed to work over 20 hours per week on campus during the summer, from 04/25/2024 – 08/09/2024. ***

*** If the student will only register Summer A with degree certification in Summer A, the student may only work until 06/21/2024.

Summer 2024 Commencement is on 08/10/2024 for most students.

A student who ...

is enrolled Spring 2024,
will not graduate May, June, nor August 2024, and
expects to enroll in Fall 2024 (regardless if they enroll in Summer 2024)

... is allowed to work over 20 hours per week on campus during the summer, from 04/25/2024 - 08/21/2024.

Fall 2024 classes start 08/22/2024.
